The County of Powys (High Street, Llandrindod Wells) (Prohibition of Waiting) Order 1984

Notice is hereby given that on 4th April 1984, the County Council of Powys made the above-named Order under sections 1 (1), (2) and (3) and 84D (1) of the Road Traffic Regulations Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, Schedule 6 to the Road Traffic Act 1974, and Schedule 7 to the Local Government Planning and 1974, and Schedule 7 to the Local Government Planning and Land Act 1980.

This Order, which will come into operation on Monday, 16th April 1984, makes it unlawful to leave a vehicle at any time on any April 1984, makes it unlawful to leave a vehicle at any time on any day along the north-west side of that length of the County road known as High Street, Llandrindod Wells, which extends from a point approximately 192 feet (58½ metres) north-east of its junction with Gwalia Square roundabout for a distance of approximately 55 feet (17 metres) in a north-easterly direction to a point approximately 247 feet (75½ metres) north-east of that investion and which lies leavely editered to the junction and which lies largely adjacent to the frontage of the Llandrindod Wells depot of the South Wales Electricity Board. Exceptions in the Order permit waiting for the following

return within 1 hour prohibited.

The above restriction replaces the present restriction which prohibits waiting along the side of the length of road concerned between 9 a.m. and 6 p.m. on Mondays to Saturdays only. The remaining waiting restrictions in High Street will stay unchanged.
