the City Council would not want advertising displays to detract from the appearance of the area.

Under the Town and Country Amenities Act 1974 all trees in Conservation Areas are subject to the same conditions as trees covered by Tree Preservation Orders and the permission of the City Council would be required to lop or fell any such trees. *Michael C.
