DEPARTMENT OF TRANSPORT

TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he has made an Order under section 209 of the above Act entitled "The Stopping up of Highways (County of Tyne and Wear) (No. 6) Order 1984" authorising the stopping up of a part of Armstrong Road, Wallsend to enable development consisting of the provision of an advance road system for future housing development to be carried out in accordance with planning permission granted by North Tyneside Metropolitan Borough Council under Part III of the said Act and requiring the provision of a new highway maintainable at the public expense for which the Highway Authority is to be Tyne and Wear County Council.

Copies of the Order may be obtained, free of charge, on application to the Director (Transport), Northern Region, Department of Transport, Wellbar House, Gallowgate, Newcastle-upon-Tyne NE1 4TD (quoting DN 503835/1/179), and may be inspected at all reasonable hours at the offices of the North Tyneside Metropolitan Borough Council, Town Hall, High Street East, Wallsend.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 5th June 1984, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
