*The Hartlepool Borough Council (Eden Street and Ouston Street Area) (Restriction of Waiting) Order 1984*

Notice is hereby given that on 18th July 1984 Hartlepool Borough Council pursuant to arrangements made under section 101 of the Local Government Act 1972 with the County Council of Cleveland in exercise of the powers of the said County Council under sections 1 (1), (2) and (3) and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 of the Local Government Act 1972 and Schedule 6 of the Road Traffic Act 1974, made the above-named Order the effect of which will be to prohibit waiting between the hours of 7 a.m. and 7 p.m. on any day other than Sunday in the following lengths or sides of road:

##### *Ouston Street*

the east side, from a point 15 metres south of its junction with Park Road in a southerly direction for a distance measured along the said road of 40 metres;  
the west side, from a point 25 metres south of its junction with Park Road in a southerly direction for a distance measured along the said road of 30 metres.

*Back Park Road* (south), from its junction with Ouston Street to its junction with Eden Street.

##### *Eden Street*

the east side, from a point 14 metres south of its junction with Park Road in a southerly direction for a distance measured along the said road of 17 metres;  
the west side, from a point 14 metres south of its junction with Park Road in a southerly direction for a distance measured along the said road of 15 metres.

Exemptions will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods, the maintenance of roads, the supply of gas, electricity and water and for disabled persons.

A copy of the Order which will come into operation on 3rd September 1984 and of a map showing the roads to which the Order relates may be inspected between 9 a.m. and 4.30 p.m. Monday to Friday at the Civic Centre, Victoria Road, Hartlepool.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act or of any Instrument made under it, has not been complied with in relation to the Order you may, within 6 weeks from the date of publication hereof apply to the High Court for this purpose.
