## ROAD TRAFFIC REGULATION ACT 1967

*The Leeds-Exeter Trunk Road (A61) (De-restriction) Order 1984*

The Secretary of State for Transport hereby gives notice that he has made an Order under sections 72(3) and 73(1) and (2) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

The effect of the Order, which comes into operation on 9th August 1984, is that that length of the Leeds-Exeter Trunk Road (A61) in the Metropolitan District of Barnsley in the County of South Yorkshire, which extends from a point 127 metres north-east of its junction with Church Lane (C44) to a point 38 metres south-east of its junction with Hallwood Road (A629) a total distance of approximately 3,733 metres will cease to be subject to a speed limit of 30 miles per hour. On the coming into effect of the Order, no person shall drive any motor vehicle at a speed exceeding 60 miles per hour on the said length of trunk road.
