- (1) For any person to cause or permit any vehicle to wait between the hours of 8 a.m. to 6 p.m.:
 - (i) on either side of Newmarket Road for a distance of 60 metres from its junction with Hardwicke Circus;
 - (ii) on the north side of Dukes Road from its junction with Hardwicke Circus for a distance of 30 metres in an easterly direction;
 - (iii) on the north side of Dukes Road and the west side of Newark Terrace for a distance of 15 metres in either direction from the junction of those
 - (iv) on the north side of Dukes Road at the workshop entrance:
 - (v) on the south side of Dukes Road for a distance of 100 metres in an easterly direction from its junction with Hardwicke Circus.
- (2) For any person to cause or permit any vehicle to wait for longer than 1 hour between the hours of 8 a.m. and 6 p.m.:
 - (i) on the remainder of the north side of Dukes Road;
 - (ii) on the south side of Dukes Road from a point 100 metres east of its junction with Hardwicke Circus to its junction with Newark Terrace.

will come into operation on 30th July 1984.

Exceptions will be provided in the Order to permit the picking up and setting down of passengers, the loading and unloading of goods, the maintenance of the roads, the supply of gas, water and electricity and disabled persons parking.
