Amendments to the Richmond Controlled Parking Zone

Notice is hereby given that, on the application of the Council of the London Borough of Richmond upon Thames, the Greater London Council on 8th August 1984 made:

- (a) the Richmond upon Thames (Parking Places) (No. 1) Order 1984 under sections 35, 36, 37, 40 and 84D of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968; and
- (b) the Richmond upon Thames (Waiting and Loading Restriction) (Amendment No. 41) Order 1984 under sections 6 and 84D of the above-mentioned Act of 1967 as amended by the Transport Act 1968 and the Road Traffic Act 1974.

2. The general effect of the Parking Places Order will be to:

- (a) revoke the designation by the Order specified in column 1 of Schedule 1 to this notice of the parking place allocated the number specified in column 2 of that Schedule and which is situated on the highway specified in column 3 of that Schedule;
- (b) designate parking places on the highways specified in column 1 of Schedule 2 to this notice at which charges may be made by the Borough Council for vehicles authorised by the Order to be left in those parking places;
- (c) provide that the type of parking place, the maximum initial period, the rate of charge and the excess period and excess charge, payable to the Borough Council, will be as set out in columns 2, 3, 4 and 5 respectively on the said Schedule 2;
- (d) provide that the parking places will operate between 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive (Christmas Day, Good Friday and Bank Holidays excepted);
- (e) provide that the vehicles which may be left:
 - (i) in a metered parking place shall be passenger vehicles (12 seats or less), goods carrying vehicles, motor cycles and invalid carriages; and
 - (ii) in a residents' parking place shall be vehicles displaying a valid permit in a protective cover issued by the Borough Council;
- (f) provide that any unexpired time shown on a parking meter may be used free of charge and the period during which a vehicle may not return to a metered parking place will be one hour;
- (g) provide that certain vehicles may wait free of charge in certain circumstances, e.g., to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes) and vehicles left by specified disabled persons (no time limit).

3. The general effect of the Waiting and Loading Restriction Order will be further to amend the Richmond upon Thames (Waiting and Loading Restriction) Order 1976, so that a solo motor cycle parking area will be designated in Victoria Place.

4. The restrictions imposed by the Richmond upon Thames (Waiting and Loading Restriction) Order 1976 will apply to any areas previously designated as parking places and not re-designated as such as they apply in the immediate vicinity.

5. The Parking Places Order will come into operation for the purposes of the installation of parking meters and for the placing of traffic signs, etc., on 20th August 1984 and for all other purposes on 28th August 1984. The Waiting and Loading Restriction Order will come into operation on 28th August 1984.

6. A copy of each of the Orders referred to in paragraph 1 above, of the Richmond upon Thames (Parking Places) Order 1973, of the Richmond upon Thames (Waiting and Loading Restriction) Order 1976 (and of the Orders which have previously amended or applied those Orders) and of the maps which indicate each length of road to which the Orders relate can be inspected until the end of 6 weeks from the date on which the Orders were made during normal office hours on Mondays to Fridays inclusive in Room B.72, The County Hall, London SE1 7PB.

7. Copies of the Orders may be obtained from the Council's Transportation and Development Department, Room 301, South Block, The County Hall, London SE1 7PB.

8. Any person desiring to question the validity of either of the Orders or of any provision contained therein on the ground that it is not within the powers of the relevant sections of the Road Traffic Regulation Act 1967, or on the ground that any requirement of those sections of the Act or of section 84A, 84B or 84C of the Act or of any regulations made under the said section 84C has not been complied with in relation to either of the Orders may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.
