The Secretary of State for Transport hereby gives notice that he proposes to make the following Orders:—

- (1) An Order under sections 10 and 41 of the Highways Act 1980 which will provide that roads which he proposes to construct along the following routes shall become Trunk Roads as from the date when the Order comes into operation—
 - (i) a new Trunk Road consisting of a main route (the new Trunk Road) at Chingford and Walthamstow in the London Borough of Waltham Forest approximately 1-74 kilometres (1-08 miles) in length, starting 13 metres (14 yards) south-east of a point on the Trunk Road which is opposite the southern corner of the offices of the Unigate Dairy, then going generally south-eastwards and then eastwards and ending at a point on the Trunk Road approximately 34 metres (37 yards) west of the equestrian subway in Epping Forest near Pentire Road, Walthamstow;
 - (ii) three new slip roads to connect the eastbound and westbound carriageways of the new Trunk Road with a roundabout to be constructed over the main new Trunk Road at the Walthamstow Avenue and Chingford Road junction at Chingford and Walthamstow;
 - (iii) a new slip road to connect the eastbound carriageway of the new Trunk Road with a new local road which will link the slip road with the roundabout at the Walthamstow Avenue and Chingford Road junction; and
 - (iv) a new slip road to connect the eastbound carriageway of the new Trunk Road with a new local road which will link the slip road with a roundabout to be constructed at the Wadham Road and Hale End Road junction at Hale End.
- (2) An Order under sections 12, 14 and 125 of the Highways Act 1980 authorising him:
 - (a) to improve, raise, lower or otherwise alter highways,
 - (b) to stop up highways,
 - (c) to construct new highways,
 - (d) to stop up private means of access to premises, and
 - (e) to provide new means of access to premises,

on or in the vicinity of the route of the new Trunk Road mentioned in 1 (i) above and providing for the transfer of each of the said new highways to the appropriate highway authority specified therefore
