YORKSHIRE WATER AUTHORITY

DROUGHT ACT 1976

Yorkshire Water Authority (River Wharfe) (Drought) Order 1984

Notice is hereby given that on 11th September 1984 the Secretary of State for the Environment made the Yorkshire Water Authority (River Wharfe) (Drought) Order 1984 (to remain in force for 6 months from 12th September 1984) under section 1 of the Drought Act 1976 suspending:

- a restriction to which the Authority is subject as respects the abstraction of water from the river Wharfe at Lobwood at NGR SE 0757 5190 under Licence No. 2/27/19/128 as varied by Variation No. 3 dated 2nd September 1981 namely the restriction prohibiting abstraction when the flow in the river Wharfe at Addingham Low Mill is less than 260 tcm per day. The Order permits abstraction at the present authorised rate of up to 80 tcm per day whenever the flow remaining in the river at Addingham Low Mill is not less than 50 tcm per day;
- a restriction to which the Authority is subject as respects the abstraction of water from the river Wharfe at the Hollins at NGR O994 4833 under Licence No. 2/27/19/5, namely the restriction which at specified residual rivers flows between 136 and 227 tcm per day limits the rate of abstraction to a minimum of 9 tcm per day and prohibits abstraction when the residual flow is less than 136 tcm per day. The Order permits abstraction of up to 18.2 tcm per day whenever the flow remaining in the river at Ilkley Old Bridge Weir is not less than 50 tcm per day.

NOTICE OF APPLICATION TO VARY A LICENCE TO ABSTRACT WATER

Notice is hereby given that an application is being made to the West Wales Division of the Welsh Water Authority by Harold George Thomas, Mullock Farm, Dale, Haverfordwest, Dyfed, to vary licence serial number 22/61/S/27/5 to abstract water from reservoir fed by unnamed stream in fields OS 7405 and OS 6500 as shown on OS map SM 8009 8109 in the Parish of St. Ishmaels and in the County of Dyfed.

The variation applied for is: to increase the winter abstraction by 650,000 gallons to 1,200,000 gallons for use during the months of April to August (previously June) inclusive.
