The Trunk Road (A470) (Glan Conwy, Gwynedd) (Restricted Roads) Order 1984

Notice is hereby given that the Secretary of State for Wales has made an Order under sections 72 and 73 of the Road Traffic Regulation Act 1967, as amended, which will come into operation on 17th October 1984.

The effect of the Order is that no person shall cause or permit any motor vehicle to proceed at a speed exceeding 30 m.p.h. in that length of road specified in the Schedule to this notice.

A copy of the Order, together with a plan and statement of reasons for making the Order, may be inspected during normal office hours at the offices of Aberconwy District Council, Town Hall, Llandudno, during a period of 6 weeks from 21st September 1984.
