

WELSH OFFICE

The Secretary of State for Wales hereby gives notice that he proposes on the application of the South Glamorgan County Council to make an Order under section 212 of the Town and Country Planning Act 1971 for extinguishing, subject to some exceptions, any rights which persons may have to use vehicles on the length of highway described in the Schedule to this notice.

SCHEDULE

The highway to which this notice relates is at Cardiff in the County of South Glamorgan and is that length of highway known as Working Street, St. John Street and in parts as the Hayes and Queen Street, which extends from its junction with the northern side of Hills Street in a general northerly direction terminating at a point on the northern side of an irregular shaped area of Queen Street at its junction with the eastern kerb-line of Kingsway.
