CHELTENHAM BOROUGH COUNCIL

The Borough of Cheltenham (Cudnall Street) (Consolidation of Waiting Restrictions) (Variation No. 35) Order 1984 and The Borough of Cheltenham (Cudnall Street) (Prohibition of Driving) Order 1984

Notice is hereby given that Cheltenham Borough Council in accordance with arrangements made under section 101 of the Local Government Act 1972 with Gloucestershire County Council the Highway Authority and in pursuance of the powers of the said County Council under sections 1, 2 and 4 and Paragraph 27 of Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") and in exercise of all other powers it enabling in that behalf and after consultation with the chief officer of police in accordance with Paragraph 20 of Part III of Schedule 9 of the Act of 1984 proposes to make two Orders the effect of which will be:

- 1. To prohibit the waiting of vehicles at any time in parts of Cudnall Street.
- 2. To close Cudnall Street at its junction with London Road/ Copt Elm Road.

Vehicles will be permitted to wait in the parts of road mentioned in paragraphs one above for so long as may be necessary to enable:

i) a person to board or alight from the vehicle; and

(ii) goods to be loaded on to or unloaded from the vehicle.

There will also be exemptions from the terms of the proposed Waiting Restrictions Order in respect of disabled person's vabiales displaying the companying bades and analysis wehicles displaying the appropriate badge and parking disc. The Waiting Restrictions Order will not affect the rights of

vehicles to be used in the parts of road in pursuance of statu-

tory powers or duties. Full details of these proposals are contained in the draft Orders which together with maps and a statement of the Council's reasons for making the Orders may be examined at the under-mentioned address on Mondays to Friday between 9a.m.-
