CLEAN AIR ACT 1956

The City of Birmingham (Borough of Sutton Coldfield Smoke Control No. 24) Revocation Order 1984

Notice is hereby given that on 19th October 1984 The City of Birmingham District Council in exercise of the powers conferred on it by the above mentioned Act, made an Order entitled "The City of Birmingham (Borough of Sutton Coldfield Smoke Control No. 24) Revocation Order 1984" (hereinafter called "the Revocation Order") declaring the Borough of Sutton Coldfield Smoke Control Order (No. 24) 1972 to be revoked. The Revocation Order is about to be submitted to the Secretary of State for the Environment for confirmation.

The Borough of Sutton Coldfield Smoke Control Order (No. 24) 1972 will be superseded by the City of Birmingham Smoke Control (No. 542) Order 1984.

The area which was affected by the Borough of Sutton Coldfield Smoke Control Order (No. 24) 1972 (which Order will be revoked by the Revocation Order) is described in the Schedule hereto.

The Revocation Order will not come into operation until 1st October 1985 or before a later date to be determined by the Secretary of State for the Environment.

Copies of the Revocation Order may be inspected free of charge at the City Solicitor's Department, Paradise Place, Birmingham B3 3EH at all reasonable hours during a period of 6 weeks from 7th November 1984.

Within the 6 week period, any person who will be affected by the Order may object to the confirmation of the Order by notice in writing to the Secretary, Department of the Environment, Romney House, Room A634, 43 Marsham Street, London SW1 3PY.

SCHEDULE

An area enclosing properties situated in Haunchwood Drive, Sutton Coldfield, and the boundary of which is as follows:

East along the Birmingham to Walsall railway line from its junction with Eachelhurst Road to its junction with Ashurst Road, south along Ashurst Road to a point coinciding with the rear boundary of No. 45 Orton Avenue, south-west along the rear boundaries of properties situated in Orton Avenue from Nos. 45 to 3, north-west to a point coinciding with the rear boundary of No. 353 Eachelhurst Road, west along the northern boundary of No. 353 Eachelhurst Road to Eachelhurst Road, north-west along Eachelhurst Road to its junction with the Birmingham to Walsall railway line.

The City of Birmingham Smoke Control (No. 186) Order 1984

The City of Birmingham Smoke Control (No. 543) Order 1984

The City of Birmingham Smoke Control (No. 546) Order 1984

Notice is hereby given that the City of Birmingham District Council in exercise of the powers conferred on it by the above mentioned Acts, intends to make 3 Orders entitled respectively "The City of Birmingham Smoke Control (No. 186) Order 1984", "The City of Birmingham Smoke Control (No. 543) Order 1984", and "The City of Birmingham Smoke Control (No. 546) Order 1984" which will have the effect of declaring the areas described in the Schedule hereto to be Smoke Control Areas.

Subject to the exemptions provided by the Orders, and by virtue of section 11 of the Clean Air Act 1956 as amended by section 1(2) of and Schedule 2 to the Local Government Planning and Land Act 1980, on any day after the Orders have come into operation, smoke is emitted from a chimney of any building within the smoke control areas, the occupier(s) of that building shall be guilty of an offence and liable to a fine not exceeding £100 unless he proves that the emission of smoke was not caused by the use of fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

The Orders will come into operation on 1st October 1985.

Copies of the proposed Orders and of the maps referred to therein may be inspected free of charge at the City Solicitor's Department, Paradise Place, Birmingham B3 3EH, at all reasonable hours during a period of 6 weeks from 7th November 1984.

Within the said period, any person who will be affected by the Orders may object to the making of the Orders by notice in writing to the City Solicitor, Paradise Place, Birmingham B3 3EH (marking correspondence with the reference: LG/AT).

SCHEDULE

The City of Birmingham Smoke Control (No. 186) Order 1984

An area bounded on the west by Winson Green Road from its junction with Dudley Road to its junction with Handsworth New Road, continuing north along Handsworth New Road to its junction with Nineveh Road, east along Nineveh Road to its junction with Park Road, south-east along Park Road to its junction with Goode Avenue, south-west along Goode Avenue to its junction with Lodge Road and All Saints Street, then continuing south along All Saints Street to its junction with Crab Tree Road, west along Crab Tree Road to its junction with Western Road, south-west along Western Road to its junction with Dudley Road, west along Dudley Road to its junction with Winson Green Road.

The City of Birmingham Smoke Control (No. 543) Order 1984

An area bounded on the west by the Sutton Coldfield bypass from its junction with Kingsbury Road to its junction with Ox Leys Road, east along Ox Leys Road to the Birmingham District Council boundary, then following the Birmingham District Council boundary in a southerly and westerly direction to a point where it coincides with the Birmingham to Walsall railway line, north-west along the Birmingham to Walsall railway line to its junction with Kingsbury Road, north-east along Kingsbury Road to its junction with the Sutton Coldfield bypass.
