New Traffic Controls for the County of South Glamorgan

Notice is hereby given that on 25th October 1984 the County Council of South Glamorgan in exercise of its powers under sections 1, 2, 45, 46, 53 and 54 of the Road Traffic Regulation Act 1984, and Paragraphs 20 and 27 of Schedule 9 of the said Act, made an Order the general effect of which will increase car parking charges for the Cardiff Central Area Car Parks in accordance with the Schedule below. The Order will come into operation on 31st October 1984.

Copies of the Orders and plans showing the affected areas are available at the address shown below, where they may be examined during usual office hours.

If you wish to question the validity of any of the Orders or any provision contained therein, on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or on the ground that any requirement of that Act or that any instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from the 25th October 1984 apply to the High Court for this purpose.

New Traffic Proposals for the County of South Glamorgan

Notice is hereby given that the County of South Glamorgan, in exercise of its powers under the Road Traffic Regulation Act 1984, intends imposing traffic restrictions on the lengths of road referred to in Column 1 of the Schedule below.

The nature of the restriction is shown in Column 2 of the Schedule and the titles of the proposed Orders are shown in Column 3.

Exemptions to the restrictions marked with an asterisk (*) will be permitted for boarding and alighting from a vehicle; loading and unloading of goods, essential services and funerals,

for a maximum of two hours, vehicles when displaying an Orange Badge and being used for the conveyance of disabled persons.

Full details of the proposals and plans showing the location and extent of the proposed restrictions may be seen at the address shown below and, in the case of Dinas Powis at Penarth Branch Library, Stanwell Road, Penarth, during normal office hours.

Any objection you may have to any of the proposals must be submitted to me in writing by 21st November 1984 for Millicent Street and Tredegar Street and by 28th November 1984 for the remaining lengths of road, and must contain the grounds on which you object.
