The Secretary of State for Wales hereby gives notice that he proposes to make under sections 10, 12, 14, 41, 125 and 326 of the Highways Act 1980 Orders the effect of which would be as regards:

(a) the Swansea-Manchester Trunk Road (Newbridge, Ruabon and Johnstown By-Pass and Slip Roads) Order 1982 to enable him to modify provisions in Schedule 1 to that Order:
