(Off-Street Parking Places) Order 1984

Notice is hereby given that on 31st October 1984 the Rotherham Borough Council made an Order under section 35(1) and (3) of and Part IV of Schedule 9 to the Road Traffic Regulation Act and Part IV of Schedule 9 to the Road Frame Regulation Act 1984. The Order comes into operation on 16th November 1984 and will control the use of the 9 parking places at Rotherham, South Yorkshire, named in the Schedule to this notice, which shows the classes of vehicles, the days and times of operation, the maximum periods for waiting, and the scales of charges for the parking places. Vehicles displaying a disabled person's badge will be exempt from the limitations on the periods for waiting and

be exempt from the limitations on the periods for waiting and from the payment of charges.

The Order revokes the Rotherham Borough Council (Off-Street Parking Places) Order 1983, and provides for control provisions (including icentical scales of charges) which are similar to those contained in the 1983 Order except that:

(1) The additional amount of £5 (the excess charge) to be paid if a vehicle is left without proper payment in a parking place during the charging hours for longer than the initial period for which payment was made or should have been made is replaced by an excess charge of £5 to be paid if a vehicle is:

(a) left in a parking place during the charging hours without payment of the initial charge; or

(b) left in a parking place during the charging hours without there being attached to the vehicle in a conspicuous position a valid ticket showing that the

conspicuous position a valid ticket showing that the

initial charge has been paid; or

(c) left in a parking place during the charging hours for a period longer than that for which the initial charge

is shown to have been paid by a valid ticket attached to the vehicle in a conspicuous position. (The Order provides that the "initial charge" will be in accordance with the relevant scale of charge shown in the

said Schedule.)

(2) The Order does not contain any provision corresponding with the provision in the 1983 Order that the period for which a vehicle may be left in a parking place during the charging hours after the excess charge has been incurred

shall not exceed 2 hours. The parking place numbered 1 in the said Schedule replaces the parking place currently bearing the same name and currently controlled by the 1983 Order, which is no longer available for use

The parking place numbered 9 in the said Schedule is in area a reduced version of the parking place currently bearing the same name and currently controlled by the 1983 Order, part of that parking place to be deleted from the control arrangemen's as that part is no longer owned by the Council.
