Notice under Regulation 3 of the Diseases of Fish Regulations 1984 (S.I. 1984/455)

Notice is hereby given that the Secretary of State for Wales, having reasonable grounds for suspecting that certain inland waters are infected, has made The Diseases of Fish (Designated Areas) (Wales) (No. 2) Order 1984.

The Order designates one area for the purpose of section 2 of the Diseases of Fish Act 1937 (c.33), as amended by the Diseases of Fish Act 1983 (c.30) and prohibits the taking of any live Atlantic salmon or live eggs of Atlantic salmon out of the designated area without the previous consent in writing of the Secretary of State for Wales.

The designated area comprises the Chirk Fishery Company Limited at Chirk, Wrexham, Clwyd.

This Order came into force on 4th November 1984.
