TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he has made an Order under section 209 of the above Act entitled "The Stopping Up of Highways (County of Shropshire) (No 1) Order 1985", authorising the stopping up of Station Road and a section of Oswald Road, Oswestry and requiring the provision of a new road, footpaths and the improvement of a highway.
