

SOUTH GLAMORGAN COUNTY COUNCIL

New Traffic Controls for the County of South Glamorgan

Notice is hereby given that on 28th February 1985 the County Council of South Glamorgan in exercise of its powers under section 1, 2 and 9 of the Road Traffic Regulation Act 1984, and Paragraphs 20 and 27 of Schedule 9 of the said Act, made an Order the general effect of which is to impose traffic restrictions on the lengths of road referred to in Column 1 of the Schedule below for an experimental period not exceeding 18 months. The nature of the restriction is shown in Column 2.

The Order will come into operation on 10th March 1985 or on the date that the necessary lines and signs are placed on site, whichever is the later, and its title is shown in Column 3 of the Schedule.

Copies of the Order and plan showing the affected areas are available at the address shown below, or the Vale of Glamorgan Borough Council, Civic Offices, Holton Road, Barry, where they may be examined between the hours of 9 a.m. - 1 p.m. and 2 p.m. - 5 p.m.

If you wish to question the Order's provisions or validity on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the ground that any requirement of, or any instrument made under the Act, has not been complied with in relation to the Order, you may, within 6 weeks from the 28th February 1985 apply to the High Court for this purpose.

*Stopping Up of a Portion of Highway Adjoining the Clans
Stonehill Road Headley Down*

Notice is hereby given that Hampshire County Council propose to make application to the Magistrates' Court sitting at the Court House, 25 Normandy Street, Alton at 10 a.m. on Thursday, 11th April 1985 for an Order under section 116 of the Highways Act 1980 stopping up a portion of highway adjoining The Clans, Stonehill Road, Headley Down which is surplus to highway requirements. A plan showing coloured blue the length of highway the subject of the proposed application has been deposited at Headley Down Post Office where it may be inspected during usual office hours. tion, the applicant authority, any person to whom notice is required to be given under Paragraph 1 of the Twelfth Schedule to the Highways Act 1980, any person who uses the highway and any other person who would be aggrieved by the making of the Order applied for, shall have the right to be heard.
