The effect of the Direction is to remove the following class of "permitted development" set out in paragraph 1 of Class II of Schedule 1 to the General Development Order 1977

The erection or construction of gates, fences, walls or other means of enclosure (other than for the purpose

of agriculture) not exceeding 1 metre in height where abutting on a highway used by vehicular traffic or 2 metres in height in any other case and the maintenance, improvement or alteration of any such gates, fences, walls or other means of enclosure

The provisions of paragraph 3 (b) of Article 4 applies to the Direction which became operative as from 2nd April 1985 and remains in force for a period of 6 months and will then expire unless it has been confirmed by the Secretary of State for the Environment. With effect from the above date no development of the class referred to can be undertaken without specific planning permission
