### MIDDLESBROUGH BOROUGH COUNCIL

*Middlesbrough Borough Council (Gulkes Street) Prohibition of Waiting Order 1985*

Notice is hereby given that on 28th March 1985, Middlesbrough Borough Council acting as agents for Cleveland County Council made an Order under section 1 of the Road Traffic Regulation Act 1984.
