

The Order as made provides for the purchase of

(a) the land and rights described in Schedule 1 hereto for the purpose of

(i) the construction of a new trunk road from a point on the A36 West of Southampton to Bath Trunk Road west of its junction with the B390 Heytesbury to Chitterne Road in a generally westerly direction to a point on the A36 south-east of its junction with the B3095 Heytesbury to Mere Road all at Heytesbury in the District of West Wiltshire in the county of Wiltshire in pursuance of the West of Southampton-Bath Trunk Road A36 (Heytesbury Bypass) Order 1985,

(ii) the improvement of a highway in the vicinity of the route of the new trunk road in the said District and County in pursuance of the West of Southampton-Bath Trunk Road A36 (Heytesbury Bypass, Side Roads) Order 1985, and

(iii) the improvement of the A36 West of Southampton to Bath Trunk Road in the vicinity of the route of the new trunk road in the said District and County,

(b) the land described in Schedule 2 hereto for the purpose of mitigating any adverse effect which the existence or use of the highway proposed to be constructed by him as mentioned above will have on the surroundings thereof

Copies of the Order as made by the Secretary of State and of the plan referred to therein, together with copies of the above-mentioned Trunk Road Order and Side Roads Order, both with their accompanying plans, have been deposited and may be seen at all reasonable hours from 20th April 1985 to 7th June 1985 at the Department of Transport, 2 Marsham Street, London SW 1, and at the offices of the Director (Transport) South West Region, Tollgate House, Houlton Street, Bristol, at the Wiltshire County Council, County Hall, Trowbridge, Wiltshire, at Warminster Public Library, New Library Building, Three Horseshoes Mall, Warminster and at the Post Office, High Street, Heytesbury, Wiltshire

The Order as made becomes operative on the date on which this notice is first published but a person aggrieved by the Order may, by application to the High Court within 6 weeks from the operative date, question its validity on the grounds

- (i) that the authorisation granted by the Order is not empowered to be granted, or
- (ii) that his interests have been substantially prejudiced by failure to comply with any statutory requirement relating to the Order
