Notice is hereby given that concurrent Public Local Inquiries will be held by Major-General M E Tickell, CBE, MC, MA, CEng, FICE, an Inspector appointed by the Secretaries of State for the Environment and Transport, on the nomitaries of State for the Environment and Transport, on the nomination of the Lord Chancellor, in connection with the Orders specified below and separately by the Secretary of State for the Environment in connection with the Applications to him for the three Certificates in respect of the Eltham Park, Oxleas Wood and Falconwood Field open space, the Rockcliff Gardens open space and the Plumstead Common open space, referred to below The Inquiries will begin at 10 30 a m on Tuesday, 10th September 1985 at the Town Hall, Wellington Street, Woolwich, London S E 18 At the inquiries the Inspector will bear representations from statutory objectors (as defined in hear representations from statutory objectors (as defined in the Highways (Inquiries Procedure) Rules 1976) and from persons interested in the land concerned and also, at his discretion, he will hear representations from any other persons who may desire to appear and be heard

section 2 of the Acquisition of Land Act 1981 The Order, f made, will authorise the Secretary of State for Transport to purchase compulsorily the land described therein for the purpose of the construction of new trunk roads in pursuance of the Trunk Road, Slip Roads and Bridge Order, for the purpose of the construction and improvement of highways and the provision of new means of access in pursuance of the Side Roads Order, for the purpose of mitigating any adverse effect which the existence or use of certain of those new and improved highways will have on the surrounding land, and for the purpose of providing exchange land for the open space land included in the Compulsory Purchase Order

- (4) The A406 London North Circular Trunk Road (East London River Crossing (A13 to A2) Supplementary Side Roads) Order 198 , hereinafter referred to as "the Supplementary Side Roads Order", notice of which was published on 28th November 1984, is an Order under section 14 of the Highways Act 1980 which, if made, will authorise the Secretary of State for Transport Secretary of State for Transport
- (a) to stop up lengths of highways, and (b) to construct new highways (which will be footpaths), all in the London Boroughs of Greenwich and Bexley
- (5) The A406 London North Circular Trunk Road (East London River Crossing, A13 to A2) Supplementary Compulsory Purchase Order (No) 198 notice of which was published on 28th November 1984, is an Order under sections 239, 240 and 246 of the Highways Act 1980 (as extended and supplemented by section 250 of that Act), and under section 2 of the Acquisition of Lond Act 1981. and under section 2 of the Acquisition of Land Act 1981 The Order, if made, will authorise the Secretary of State for Transport to purchase compulsorily the land described therein for the purpose of the construction of new trunk roads, in pursuance of the Trunk Road, Slip Road and Bridge Order, for the purpose of the construction and improvement of other highways and provision of new means of access in the London Boroughs of Greenwich and Bexley in pursuance of the Side Roads Order and Supplementary Side Roads Order, for the purpose of mitigating any adverse effect which the existence or use of certain of the highways to be constructed or improved will have on the surrounding land, and for the purpose of providing exchange land for the open space land included in the Compulsory Purchase Order and the Supplementary Compulsory Purchase Order

 (b) to construct a new highway at Winsor Terrace,
