The (A19) East of Snauth-York-Thirsk-Stockton-on-Tees-Sunderland Trunk Road (Parkway Interchange to County Boundary at Crathorne) (24 Hour Main Carriageway Clearway) Order 198

The Secretary of State for Transport proposes to make an Order under sections 1 (1) and (2), 2 (1) and (2), 3 (2) and 4 (1) of the Road Traffic Regulation Act 1984 on the East of Snauth to Sunderland Trunk Road (A19) in the Boroughs of Stockton-on-Tees and Middlesbrough in the County of Cleveland

The effect of the Order will be to prohibit waiting on any of the main carriageways (including the carriageways of the slip roads) forming part of that length of the trunk road A19 which extends from its junction with the A174 at Parkway Interchange southwards for a distance of about 6.5 kilometres (4 miles) to the Cleveland/North Yorkshire County Boundary at Crathorne

The prohibitions imposed by the Order will not apply

- (a) to a vehicle waiting upon the direction or with the permission of a police constable in uniform or of a traffic warden,
- (b) so as to prevent a vehicle being used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or of any of the services thereon,
- (c) to a vehicle being used for police, ambulance or fire brigade purposes,
- (d) to a vehicle being used in the service of a local authority or of a water authority in pursuance of statutory powers or duties, or
- (e) to a vehicle waiting when the person in control of it is

- (i) required by law to stop,
- (ii) obliged to stop to avoid an accident, or
- (iii) prevented from proceeding by circumstances outside his control
