SCHEDULE

(All distances are approximate)

The highway to be stopped up is at Newport in the County of Gwent and is a 4 metre wide length on the south-western side of Wolesley Street which extends from a point 4 metres north of the north-western kerbline of Watch House Paradeina general north-westerly direction for a distance of 27 metres (4 SI)
