IMPORTATION OF ANIMAL PRODUCTS AND POULTRY PRODUCTS ORDER 1980 (AS AMENDED)

Notice is hereby given that as provided by Article 4 of the Importation of Animal Products and Poultry Products Order 1980 (as amended) the Ministry of Agriculture, Fisheries and Food and the Welsh Office Agriculture Department have with effect from 17th April 1985 revoked the following general licences and replaced with new general licences with amended conditions as detailed below.

Conditions attaching to licence A

A Each consignment must be accompanied by a certificate in accordance with the terms of the Decision of the Council 85/96 EEC taken under Council Directive 72/462/EEC on health problems affecting imports of fresh meat from Uruguay, signed by an official veterinarian of the Government of Uruguay stating:

- (1) (a) Details of consignment.
 - (b) Address(es) and veterinary approval number(s) of the slaughterhouse/cutting plant
 - (c) Destination of meat including means of trans-
- (2) Health attestation.

The fresh meat described above is obtained from animals which have remained in the territory of Uruguay for at least 3 months before being slaughtered or since birth in the case of animals less than 3 years old
