#### **NEW TOWNS ACT 1981**

The Aycliffe and Peterlee New Towns (Transfer of Functions) Order 1985

Whereas

(1) the Aycliffe New Town (Designation) Order 1947 (S R &O 1947/323) designated as the site of the new

(2) the Aycliffe New Town (Development Corporation) Order 1947 (S R &O 1947/678) established a corporation

to be known as the Aycliffe Development Corporation for the purposes of the development of a new town on the site designated by the Aycliffe New Town (Designation) Order 1947.

(3) the area of land designated as the site of a new town by the Aychiffe New Town (Designation) Order 1947 was altered by the Aychiffe New Town (Designation) (Amendment) Order 1966 (SI 1966/413) and the Aychiffe New Town (Designation) (Amendment) Order 1974 (SI 1974/3),

(4) the Easington New Town (Designation) Order 1948 (SI 1948/473) designated as the site of a new town an area of land in the county of Durham,

(5) the Peterlee Development Corporation Order 1948 (SI 1948/583) established a corporation to be known as the Peterlee Development Corporation for the purposes of the development of a new town on the site designated by the Easington New Town (Designation) Order 1948,

(6) the area of land designation of the 1948, town by the Easington New Town (Designation) Order 1948 was altered by the Easington New Town (Designa-tion) Amendment (Peterlee) Order 1965 (S I 1965/1416), the Easington New Town (Designation) Amendment (Peter-lee) Order 1969 (S I 1969/1730) and the Easington New Town (Designation) Amendment (Peterlee) Order 1978 Town (Designation) Amendment (Peterlee) Order 1978 (SI 1978/866),

(7) it appears to the Secretary of State for the Environment, after consulting the Aycliffe and Peterlee Develop-ment Corporations, that there are exceptional circumstances which render it expedient that the functions of the Peterlee Development Corporation should be transferred to the Aycliffe Development Corporation, and
