ROAD TRAFFIC ACTS

LINCOLN CITY COUNCIL

The City of Lincoln (Various Roads) (General Traffic Regulation) Order 1985

Notice is hereby given that the Council of the City of Lincoln as agents for Lincolnshire County Council, on 16th July 1985 made the above Order under sections 1(1) and (2), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984

The effect of the Order which comes into operation on 22nd July 1985 is

- (a) to revoke the Order specified in Schedule 1 to this Notice,
- (b) to introduce no waiting at any time on the lengths of road specified in Schedule 2 to this Notice,
- (c) to introduce no waiting between 8 a.m. and 6 p.m., Monday to Saturday on the lengths of road specified in Schedule 3 to this Notice, and
- (d) to introduce no entry except for access on the lengths of road specified in Schedule 4 to this Notice

The Order contains exemptions which will permit waiting for disabled persons vehicles and for the purpose of picking-up and setting down passengers and loading and unloading goods, the maintenance of the roads, works in connection with the supply of gas, electricity and water and under the Telegraph Acts and for building or demolition works and for vehicles used in connection with weddings and funerals

Copies of the Order and plans showing the roads affected may be inspected during normal office hours at the Chief Executive's and City Engineer's Departments, City Hall, Lincoln

Any person who wishes to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of that Act or any regulation made under it have not been complied with may within 6 weeks of 16th July 1985 apply to the High Court for that purpose
