

picking up or setting down of passengers, the carrying out of statutory powers or duties, the taking in of petrol, etc, from roadside petrol stations, to licensed street traders, etc

5 The requirements and prohibitions referred to in paragraph 2 (3) to (6) inclusive would not apply to anything done in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police

6 The effect of the Parking Places Order would be to revoke the designation by the Camden (Parking Places) (No 1) Order 1976 of the 2-hour metered parking place numbered 18 therein which is situated on the north-west side of Bedford Avenue

7 The restrictions imposed by the Camden (Waiting and Loading Restriction) Order 1976 would apply to the area previously designated as a parking place as they apply in the immediate vicinity

8 A copy of each of the proposed Orders, of the above-mentioned Regulations, of 1961 and Orders of 1976 (and of the Orders which have amended or applied those Regulations and Orders) and of the Council's statement of reasons for proposing to make the Order can be inspected during normal office hours on Mondays to Fridays inclusive until the expiration of a period of 21 days from the date on which this notice is published in Room B 72, The County Hall, London SE1 7PB
