#### WELSH OFFICE

The Secretary of State for Wales hereby gives notice that he has made an Order under section 209 of the Town and Country Planning Act 1971 to authorise the stopping-up of the highways described in the Schedule to this notice to enable development to be carried out

The Order will require the provision of a new highway to be a turning bay for vehicles and maintainable at public expense, for which the highway authority shall be Mid Glamorgan County Council

Copies of the Order may be inspected free of charge at all reasonable hours at the offices of Merthyr Tydfil Borough Council, Town Hall, Merthyr Tydfil, Mid Glamor-

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 17th October 1985 apply to the High Court for the suspension or quashing of the Order or of any provision contained

#### SCHEDULE

(All distances are approximate)

The highways to be stopped-up are in the Borough of Merthyr Tydfil in the County of Mid Glamorgan, and

(a) that length of Abermorlais Terrace which extends from its western termination point in an easterly direction for a distance of 73 yards,

(b) that length of footpath which extends from its junction with Abermorlais Terrace in a south-easterly direc-tion for a distance of 57 yards (3 SI)
