- (b) the proposals shown on Site Plan No. 3 (as varied) of the draft Swansea-Manchester Trunk Road (New-bridge, Ruabon and Johnstown By-pass and Slip Roads, Side Roads) Order 1982 (Variation) (No. 2 Order 19 in so far as these proposals relate to all the area south of an east-west line which intersects a point 230 yards (210 metres) north of the junction of Low Barracks Road with Black Park Road at Halton in the County of Clwvd: and of Clwyd; and
- (c) the land and rights from the draft Swansea-Manchester Trunk Road (Newbridge By-pass) Com-pulsory Purchase Order 19 described in the Schedule hereto

These withdrawals are made after consideration of objections received to the above-mentioned draft Orders when they were published, and in the light of the National Coal Board's proposals to undertake opencast mining at Ley Farm on the intended line of the by-pass.
