GREATER LONDON COUNCIL

The Greater London (Restriction of Goods Vehicles) (Amendment No.) Traffic Order 1985

Notice is hereby given that the Greater London Council propose to make the above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

2. The effect of the Order would be further to amend the Greater London (Restriction of Goods Vehicles) Traffic Order 1985, so that vehicles whose use on roads is authorised by or on behalf of the Commissioner of Police of the Metropolis would be exempted from the prohibition on goods vehicles imposed by that Order.

3. A copy of the proposed Order, of the above-mentioned Order of 1985, and of the Council's statement of reasons for proposing to make the Order can be inspected during normal office hours on Mondays to Fridays inclusive until the expiration of a period of 21 days from the date on which this notice is published, in Room B.72, The County Hall, London SE1 7PB.

The Barnet (Waiting and Loading Restriction) (Amendment No. 69) Order 1985

Notice is hereby given that the Greater London Council on 2nd December 1985 made the above-mentioned Order under sections 6 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

2. The general effect of the Order will be further to amend the Barnet (Waiting and Loading Restriction) Order 1978, so that in the lengths of streets specified in the Schedule to this notice the hours during which the existing prohibition on waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) applies will be changed so that such prohibition will apply between 8 a.m. and midnight on Mondays to Saturdays inclusive.
