## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

Notice is hereby given that the Secretary of State for Transport intends to make an Order on the London-Edinburgh-Thurso Trunk Road A1 (M) known locally as the Great North Road, in the District of Richmondshire in the County of North Yorkshire and the District of Darlington in the County of Durham to enable works to be carried out.

The effect of the Order will be to close temporarily to all traffic:

- (a) that length of the A1 (M) Trunk Road which extends from a point 750 metres south of the centreline of Barton Bridge to a point 400 metres north of the centreline of Barton Bridge, a total distance of 1,150 metres. (b) that length of the A1 (M) Trunk Road which extends
- from a point 650 metres south of the centreline of the A66 (M) sliproad bridge to a point 100 metres north of the centreline of the A67 Merrybent Bridge, a total distance of 3,500 metres.

The Order will come into operation at 0001 hours on 20th January 1986 and will remain in force until all the works have been completed, a period of approximately 17 weeks.

The works will be carried out during four separate periods on the northbound and southbound carriageways of each length of trunk road referred to above. All traffic will be diverted onto the opposite carriageway using a contra-flow system which will prohibit the overtaking of any other moving vehicle.

The above prohibition shall not apply to vehicles being used in connection with the said works, or for police, fire brigade or ambulance purposes, and they shall apply only during such times and to such extent as shall be indicated by the appropriate traffic signs. The provisions of Regulation 6 (3) of the Motorways Traffic (England and Wales) Regulations 1982 will be sus-

pended as required during the works periods.

## **HIGHWAYS ACT 1980**

The (A65) North-West of Doncaster-Kendal Trunk Road (Settle and Giggleswick Bypass Side Roads Variation) Order 1985.
