NEW TOWNS ACT 1981

The New Town of Basildon: Extinguishment of Public Rights of Way Great Berry Housing Area, Basildon

Notice is hereby given that the Secretary of State for the Environment in exercise of his powers under section 23 of the New Towns Act 1981 has made an Order extinguishing as from the date of the Order the public rights of way over the following rights of way, shown coloured blue on the map hereinafter referred to:

That part of Forest Glade starting from a point marked A on the map 160 feet from its junction with Beech Hall Gardens extending eastwards for a distance of 790 feet and then running northwards for a distance of 170 feet to point B on the map.

That unmade part of Berry Lane extending eastwards (point C on map) for a distance of 210 feet to point D on the map.
