Her Majesty The QUEEN by Royal Warrant bearing date 11th January 1986 has been graciously pleased to ordain and declare that Helen Moncrieff Motteux the sister of George Miles, Earl of Buckinghamshire should henceforth have, hold and enjoy the same title, rank and pre-eminence and precedence as the daughter of an Earl which would have been due to her had her father Cyril Langel Hobart-Hampden survived his kinsman Vere Frederick Cecil, Earl of Buckinghamshire and thereby succeeded to the title and dignity of Earl of Buckinghamshire.

And to command that the said Royal Concession and Declaration be recorded in Her Majesty's College of Arms.

THE TRUNK ROAD (A494) (RHOS STREET, RUTHI CLWYD) (PROHIBITION OF TRAFFIC) ORDER 1986

Notice is hereby given, that the Secretary of State for Wales proposes to make an Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984

The effect of the proposed Order will be to prohibit, with certain exceptions the waiting of vehicles in the length of the road specified in the Schedule to this Notice.

A draft Order, together with a plan and statement of reasons for making the Order, may be inspected during normal office hours at the offices of Ruthin Town Council, Town Hall, Ruthin.

SCHEDULE

That length of the Dolgellau-South of Birkenhead Trunk Road (A494) known as Rhos Street at Ruthin in the county of Clwyd, which extends from its north-easterly junction with Wernfechan in a general north-easterly direction to a point 238 metres north-east of the said junction.

The Secretary of State for Wales hereby gives notice that he has, on the application of Port Talbot Borough Council, made an Order under section 212 of the Town and Country Planning Act 1971 extinguishing, subject to some exceptions, any rights persons may have to use vehicles on the lengths of highway described in the

Schedule to this Notice.

Copies of the Order may be inspected free of charge at all reasonable hours at the offices of Port Talbot Borough Council,

reasonable nours at the offices of Port Taibot Borough Council, Municipal Buildings, Aberavon Seafront, Port Taibot. A copy of the Inspector's Report of the Public Local Inquiry held between 30th April and 2nd May 1985 will also be available for inspection.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 29th January 1986, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
