The Thanet District Council (Off-street Parking Places) Order 1986

Notice is hereby given that the Thanet District Council has made an Order under section 35 (1) and (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 on 20th March 1986 to control the use of its off-street parking places. The Order will come into effect on 1st April 1986.

The Schedule to the Order shows the parking places divided into three categories, i.e., Part I—free parking Part II—standard charges and Part III—'short stay', the classes of vehicles, the days and time of operation, the maximum period of waiting and (where applicable) the scale of charges and the concessions for period ticket holders for each parking place.

The Charges are:

(a) *Standard charges:*

Long term:

- Up to 2 hours, 20p;
- Up to 4 hours, 40p;
- Up to 6 hours, 60p;
- Over 6 hours, £1;
- H.G.V. overnight, £1.

Seasonal car parks:

- Before 3 p.m., £1;
- After 3 p.m., 50p;

Coaches:

- Up to 2 hours, £1.50p;
- Up to 4 hours, £2.50;
- Over 4 hours, £3.50.

Broadstairs and Ramsgate Harbour Car Parks:

Broadstairs:

- Before 2 p.m., £1.20;
- After 2 p.m., 75p.

Ramsgate:

- Any period up to 4 hours, 70p.

(b) *Short stay:*

- Per. entry, 25p (maximum stay 2 hours).

(c) *Period tickets (applicable to specified car parks only):*

Private cars/light vans:

- Annual, £125;
- ½-year 1st April to 30th September, £81;
- ¼-year, 1st October to 31st March, £69;
- Quarterly, 1st April to 30th June, £37.50;
- Quarterly, 1st July to 30th September, £50;
- Quarterly, 1st October to 31st December, £37.50;
- Quarterly, 1st January to 31st March, £37.50;
- Weekly, £4;

Coach/Lorry:

- Weekly, £17.50.

The Order includes exemptions from any time limits and from the payment of any charges for invalid carriages, vehicles issued to disabled persons in lieu of invalid carriages, disabled persons' vehicles displaying a disabled person's badge.

The Order will specify the conditions under which the parking places may be used. Full details are contained in the Order and Schedule, which, together with a map showing the situation of the parking place, may be seen, during normal office hours, at:

Thanet District Council (Parking Places in Cecil Square, Margate, Kent) Order 1984 (Variation) Order 1986

Notice is hereby given that the Thanet District Council, in exercise of powers delegated to it by the Kent County Council, has made the above Order under the Road Traffic Regulation Act 1984 and all other enabling powers on 20th March 1986. The Order will come into operation on 1st April 1986.

The effect of the Order is to:

- (a) increase the "excess charge" from £10 to £15; and
- (b) provide for the parking of disabled persons' vehicles only in certain marked spaces.
