SOLIHULL METROPOLITAN BOROUGH COUNCIL

The Metropolitan Borough of Solihull (Off-Street Parking Places) (Solihull) (Amendment) (No.6) Order 1986

Notice is hereby given that the Solihull Metropolitan Borough Council propose to make the above-mentioned Order under section 46 of the Road Traffic Regulation Act 1984. The effect of the proposed Order will be to increase the scale of car parking charges for the Link Road, Civic Centre and George Road Car Parks as follows:

- (a) The hourly rates of charge are to be:

30p for up to two hours;
35p for up to three hours;
50p for up to four hours;
65p for up to five hours;
80p for up to six hours;
£1 for over six hours.

(b) Season tickets to be £185 for 12 months and £50 for three months.

Full details are contained in the draft Order which may be inspected at the Council House, Solihull, during normal Office hours.

CHESTERFIELD BOROUGH COUNCIL

Chesterfield Borough Council (Mansfield Road/The Green, Hasland) (Waiting Restriction) Order 1986

Notice is hereby given that the Chesterfield Borough Council pursuant to arrangements made under section 101 of the Local Government Act 1972 with the Derbyshire County Council and in exercise of the powers conferred by sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 intend to make an Order, the effect of which will be to introduce the following restrictions:

- (i) *No Waiting At Any Time*

Mansfield Road —from a point 35 metres west of its junction with Chapel Lane East for a distance of 65 metres in a westerly direction.

Mansfield Road —from its junction with The Green in an easterly direction for a distance of 20 metres.

- (ii) *Waiting Limited to One Hour with Return Prohibited within Two Hours between 8 a.m. and 6 p.m. Monday to Saturday*

Mansfield Road —From its junction with Chapel Lane East in a westerly direction for a distance of 35 metres.

Exemptions will be provided in the Order to enable vehicles to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded onto or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the roads or the services therein to take in petrol, oil, water or air from any garage situated within the lengths of road; or as part of a funeral or wedding cortege. The usual exemptions for disabled person's vehicles will be provided in the order.

Full details of the proposals are in the draft Order which, together with a map showing the prohibited areas may be examined at the Town Clerk's Office on any weekday, during normal office hours.

Should you wish to object to the proposed Order you should send the grounds of your objection in writing to the undersigned to arrive no later than 9th May 1986.
