The Walsall Metropolitan Borough (New Road and Bilston Street area, Willenhall Traffic Regulation Order 1986

The Order prohibits waiting between the hours of 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in parts of Dimminsdale, Willenhall; prohibits waiting at any time in parts of Bilston Street, Ensdale Row, New Road and Walsall Street; prohibits traffic from proceeding in part of Ensdale Row and revokes parts of the Walsall Metro-politan Borough (Willenhall Town Centre) Traffic Regulation Order 1979, as it relates to New Road, Bilston Street, Walsall Street and Dimminsdale, Willenhall.

The Order contains exemptions for the following:

Loading and unloading; building, demolition and similar operations; delivering or collecting postal packet; disabled persons to wait for up to 2 hours; a local authority or water authority to act in pursuance of statutory powers or duties; in an emergency for fire brigade, police or ambulance purposes or to enable a person to board or alight from a vehicle.

Subject to certain exemptions, any person wishing to fell, top, lop, etc., trees in such Areas should give the Borough Council 6 weeks' notice of intention to do so. Penalties apply in the event of violations of these controls.
