The Orders and their effects are as follows:

The City of Chester (Crook Street) Closure Order 1986

The effect of this Order will be to prohibit all vehicles from proceeding in Crook Street from a point 18 metres north of its junction with Watergate Street for a distance of 9 metres in a northerly direction.

The City of Chester (Heath Lane, Great Boughton) (Pro-hibition of Driving) Order 1986

The effect of this Order will be to prohibit all vehicles except cycles from proceeding in Heath Lane from its junction with Caldy Valley Road and a point 140 metres north-west of that junction.

The City of Chester (Northgate Street|Water Tower Street) (Prohibition of Right Turn) (Revocation) Order 1986

The effect of this Order will be to permit vehicles to make a right turn from Upper Northgate Street into Water Tower Street, a manoeuvre which is presently prohibited.

City of Chester (Garden Lane Area) (Traffic Management) Order 1986

The effect of this Order will be to prohibit waiting at any time on the following lengths of road:

Lorne Street, both sides, from a point 10 metres south of the centre line of West Lorne Street to a point 9 metres north of the centre line of West Lorne Street. West Lorne Street, both sides, from its junction with Lorne Street for a distance of 8 metres in a westerly direction.

The Order will also consolidate other restrictions in the immediate vicinity.
