

ROYAL COUNTY OF BERKSHIRE

*Royal County of Berkshire (Various Roads, Maidenhead) Traffic Regulation Order 1986*

Notice is hereby given that the County Council of the Royal County of Berkshire propose to make an Order under sections 1 (1) and (2), 2 (1) to (3), 4 (1) and (2), 45, 46, 49, 53 and 124 (1) (d) of the Road Traffic Regulation Act 1984 the effect of which is to:

- (1) Prohibit any vehicle from waiting at any time in the lengths of road specified in Schedule 1 to this notice.
- (2) Prohibit any vehicle from waiting during the hour of 9 a.m. to 10 a.m. in the lengths of road specified in Schedule 2 to this notice.
- (3) Designate the lengths of road specified in Schedule 3 to this notice as residents' parking places between the hours of 8 a.m. to 5 p.m. Monday to Saturday where residents of the lengths of road specified in Schedule 4 who display a residents' parking permit may park for unlimited periods.
- (4) The charge for permits will be £5 per annum and free to persons of state pensionable age or who are registered disabled.
- (5) Designate the length of road specified in Schedule 5 as a disabled person's parking place.
- (6) Place a box junction in the length of road specified in Schedule 6 to this notice.
- (7) Revoke the following Orders insofar as they relate to the lengths of road specified in the Schedule to this notice:
  - (i) Borough of Maidenhead (Various Roads) (Consolidation of Waiting Restrictions and One-way Traffic Order 1972.
  - (ii) The Borough of Maidenhead (Various Roads) Traffic Regulation Order No. 2 1972.
  - (iii) The Borough of Maidenhead (Various Roads) Traffic Regulation Order 1974.

Copies of the draft Order, explanatory statement and map can be inspected during the hours of 9 a.m. to 4.30 p.m. Mondays to Fridays at the offices of the Royal Borough of Windsor and Maidenhead and at the County Secretary's Department at the address given below.

SCHEDULE 1

*Prohibition of waiting at any time*

*Rushington Avenue*, both sides, from its junction with Braywick Road westwards for a distance of approximately 68 metres.

*Cedars Road*

North and West side, from its junction with Forlease Road, east and northwards for a distance of approximately 80 metres.

South side, from its junction with Forlease Road eastwards for a distance of approximately 35 metres.

SCHEDULE 2

*Prohibition of waiting 9 a.m. to 10 a.m.*

*Rushington Avenue*, both sides, from a point approximately 68 metres from its junction with Braywick Road southwards for a distance of approximately 92 metres.

SCHEDULE 3

*Residents' parking*

*Bell Street*, north side, from a point approximately 5 metres west of the eastern end of Bell Street (the boundary between Nos. 23-25) westwards for a distance of approximately 85 metres.

*Reform Road*, east side, from a point approximately 12 metres south of the northern end of Reform Road southwards for a distance of approximately 34 metres (the southern boundary of No. 9).

*Issue of permits to residents of Bell Street and Reform Road, Maidenhead*

*Disabled Parking Place*

Outside No. 2 West Dean.

SCHEDULE 6

*Box Junction*

In the junction of A4, Bath Road/All Saints Avenue/Boyn Hill Road.

*Metropolitan Borough of Bury (Parks Yard, Bury) (Prohibition of Waiting) Order 1986*

Notice is hereby given that the Council of the Metropolitan Borough of Bury propose to make an Order under sections 1 (1) and (2) and 2 (1) to (3) and 4 (2) of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit the waiting of vehicles at any time on the following length of road:

*Parks Yard, Bury*, both sides, from a point 10 metres west of Silver Street to the westerly kerb-line of Back Silver Street.

Exceptions will be included in the Order to permit waiting for boarding or alighting, loading or unloading, funerals, building operations or work on or under the length of road referred to in the paragraph above. Disabled persons' vehicles bearing a disabled person's badge and a parking disc will be allowed to wait for up to 2 hours, return prohibiting within 1 hour in the length of road referred to in the paragraph above.

A copy of the proposed Order and a map showing the road to which it relates, together with a statement of the Council's reasons for proposing to make the Order may be examined at the Department of Administration, Town Hall, Bury, during normal office hours.

Objections to the proposals, together with the grounds on which they are made must be made in writing and sent to the Director of Administration by 29th August 1986.
