NOTICE OF SUBMISSION OF PROPOSALS FOR REGULATIONS REVISING THE PRESENT SYSTEM OF HELP FOR SUPPLEMENTARY BENEFIT CLAIMANTS DURING PERIODS OF EXCEPTIONALLY SEVERE WE ATTIED WEATHER

The Social Security Advisory Committee gives notice that it has been asked by the Secretary of State for Social Services under section 10 of the Social Security Act 1980 to consider and report on proposals for regulations revising the present system of help for supplementary benefit claimants during periods of exceptionally severe weather.

A short explanatory note provided by the Department of Health and Social Security on these proposals is appended to this notice. The Committee will take into account any comments or objections made by or on behalf of people or organizations who would be affected by the proposals received by them not later than 8th September 1986. #### **EXPLANATORY NOTE**

The Secretary of State for Social Services proposes to make amendments to the supplementary benefit regulations. The proposed changes will specify the circumstances in which the Secretary of State can announce that a period of exceptionally severe weather has occurred and links local office areas with specific meteorological stations. At the same time the groups eligible for help will be prescribed as will the amount of help available during a period of exceptionally severe weather.
