#### TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that on the application of the North Tyneside Metropoli-tan Borough Council, he proposes to make an Order under section 212 of the above Act to provide for the extinguish-ment of any right which persons may have to use vehicles on 2 lengths of Balkwell Green, North Shields, Tyne and Wear.

The proposed Order will contain provisions for permitting the use of those highways by vehicles being used
