

- (cc) Prohibited at any time (part existing bus-stop Clearway to remain) on the eastern side of Wimborne Road from a point 18 metres north of the northern arm of Dean Park Road for 39 metres in a northerly direction;
- (dd) Prohibited at any time on the north-western side of Woodbury Avenue for 145 metres from Castle Lane West, and on the south-eastern side of the road for 175 metres from Castle Lane West;
- (ee) Prohibited at any time on the northern side of Castle Lane West from a point 23 metres west to a point 32 metres east of the centre line of Woodbury Avenue;
- (ff) Prohibited between 10 a.m. and 7 p.m. on the northern side of Wolverton Road from Portman Road for 10 metres in an easterly direction.

The usual exceptions will apply to picking up and setting down passengers, loading and unloading goods and, where necessary, in connection with the maintenance of the roads and the supply of gas, electricity and water.

A copy of the Order and a map showing the restricted roads are available at my office where they may be examined between 9 a.m. and 4 p.m. Mondays to Fridays.

If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act as amended or of any instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from 14th August 1986 apply to the High Court for this purpose.

Designation of Conservation Areas

Conservation Area: Costessey (West End)
