Surrey County Council (A287 Firgrove Hill, Farnham) (Weight Restriction) Order 198

Notice is hereby given that the Surrey County Council propose to make an Order under sections 1 (1) and (2), 2 and 3 (2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 the effect of which will be to prohibit heavy commercial vehicles the maximum gross weight of which exceeds 7.5 tonnes from entering or proceeding in that length of the A287 Firgrove Hill Farnham (hereinafter called "the prohibited street") which is carried by Firgrove Hill Bridge over the A31 Farnham By-pass.
