#### SCHEDULE 1

Proposed Parking Places, Spring Terrace, 10p per hour for passenger vehicles, goods vehicles not exceeding 30 cwt., invalid carriages, motor cycles and with exception for vehicles displaying a residents parking permit.

#### Location of Parking Places

##### Spring Terrace

- (1) East side, from a point 20 metres north of its junction with Albion Road to a point 18 metres east of its junction with Lovaine Place.
- (2) West side, from a point 34 metres north of its junction with Albion Road to a point 44 metres north of that junction.
- (3) West side, from a point 65 metres north of its junction with Albion Road to a point 75 metres north of that junction.
- (4) West side, from a point 130 metres north of its junction with Albion Road to a point 158 metres north of that junction.

Charges for the above parking places will be applicable between 9 a.m. and 5.30 p.m. Monday to Saturday. Any residents or their visitors whose vehicle displays a valid permit issued by the Council will be exempt from the charges.

#### SCHEDULE 2

*Prohibition of Waiting 8 a.m. to 6 p.m. Monday to Saturday*

##### Spring Terrace

- (1) West side, from its junction with Albion Road in a northerly direction of 34 metres.
- (2) West side, from a point 44 metres north of its junction with Albion Road to a point 65 metres north of that junction.
- (3) West side, from a point 75 metres north of its junction with Albion Road to a point 130 metres north of that junction.
- (4) West side, from a point 158 metres north of its junction with Albion Road to a point 18 metres east of its junction with Lovaine Terrace.
