- (a) to enter or proceed through the gap in the reservation between A3 and Malden Way South Service Road that lies 35 metres south of the Junction of A3 with South Lane; and
- (b) to make a northbound U-turn into Malden Way South Service Road at a point opposite the north-west frontage of Number 248 Malden Way. The Order would come into operation on 29th October 1986.

The Secretary of State for Transport hereby gives notice that he proposes to make the following Orders:

(1) an Order under sections 10 and 41 of the Highways Act 1980 providing that a road about 3.65 kilometres in length which he proposes to construct at or near Axminster in the county of Devon along a route at a point on the A35 Trunk Road approximately 190 metres west of the centre of the bridge which carries the trunk road over the River Yarty then going in a general easterly direction south of Axminster to rejoin the Trunk Road at a point approximately 438 metres west of its junction with the C69 road to Seaton shall become a trunk road as from the date when the Order comes into operation;

(2) a further Order under sections 10 and 12 of the Highways Act 1980 providing that part of the A35 Folkestone-Honiton Trunk Road about 4.42 kilometres in length shall cease to be a trunk road as from the date on which notice is given by the Secretary of State to the Devon County Council (who will become the highway authority responsible for that length) that the new trunk road is open for through traffic; and

(3) an Order under sections 12, 14 and 125 of the Highways Act 1980 authorising him:

- (a) to improve, raise, lower or otherwise alter highways;
- (b) to stop up highways;
- (c) to construct new highways;
- (d) to stop up private means of access to premises; and

(e) to provide new means of access to premises, all at or near Axminster aforesaid, and providing for the transfer of each of the said new highways to the County Council of Devon as from the date on which he notifies the Council that the new highway has been completed and is open for through traffic.

Copies of the draft Orders and of the relevant plans may be inspected free of charge at all reasonable hours from 26th September 1986 until 2nd January 1987 or within three months from the date of publication of this notice, whichever period shall expire later, at the Department of

#### HIGHWAYS ACT 1980

*The (A17) King's Lynn-Newark Trunk Road (New Washway Road, Saracen's Head to Laurel Lodge, Holbeach, Side Roads) Order 1986.*

The Secretary of State for Transport hereby gives notice that, in relation to the new trunk road to be constructed by him from Saracen's Head to Laurel Lodge, Holbeach in the District of South Holland in the County of Lincolnshire, he has made under sections 14 and 125 of the Highways Act 1980 an Order, the effect of which is:

(a) to authorise him:

- (i) to improve, raise, lower or otherwise alter highways;
- (ii) to stop up highways;
- (iii) to construct new highways;
- (iv) to stop up private means of access to premises; and

(v) to provide new means of access to premises;

all on or in the vicinity of the route of the above-mentioned new trunk road; and

(b) to provide for the transfer of each of the said new highways to the County Council of Lincolnshire as from the date on which he notifies the Council that the new highway has been completed and is open for through traffic.

Copies of the Order and of the relevant plans have been deposited at the Department of Transport, 2 Marsham Street, London S.W.1, and at the offices of the Director (Transport), East Midlands Region, Cranbrook House, Cranbrook Street, Nottingham; at the Lincolnshire County Council, County Offices, Lincoln; and at the Lincolnshire County Council Library, Church Street, Holbeach, Lincolnshire, where they are open to inspection free of charge at all reasonable hours.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980, or on the ground that any requirements of that Act, or of regulations made thereunder, has not been complied with in relation to the Order, may, within 6 weeks from 30th September 1986, or within 6 weeks from the date of publication of this notice, if such period shall expire later, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
