The Chester-Bangor Trunk Road (Conwy Morfa to Llanfairfechan Diversions and Slip Roads) (Variation No. 3) Order 1986.

The Chester-Bangor Trunk Road (Diversion of Colwyn Bay and Conwy Bay) (Variation No. 2) Order 1986.

The Chester-Bangor Trunk Road (Conwy Morfa to Llanfairfechan, Penmaenmawr Section Side Roads) Order 1986

The Secretary of State for Wales hereby gives notice that he has made the following Orders:

- (1) An Order under section 10 of the Highways Act 1980 authorising him to vary the powers conferred by the Chester-Bangor Trunk Road (Conwy Morfa to Llanfairfechan Diversions and Slip Roads) Order 1978 by substituting in part for the length of the route J to K in paragraph (5) of Schedule 1 to that Order the route described in Schedule 2 of the Variation Order.
- (2) An Order under sections 108 and 326 of the Highways Act 1980 authorising him to vary the powers conferred by the Chester-Bangor Trunk Road (Diversion of Colwyn Bay and Conwy Bay) Order 1978 to enable him to alter the areas of Conwy Bay to be diverted.
- (3) An Order under sections 12, 14 and 125 of the Highways Act 1980 authorising him:
 - (a) to improve, raise, lower or otherwise alter highways,
 - (b) to stop up highways,
 - (c) to construct new highways,
 - (d) to close a highway temporarily,
 - (e) to stop up private means of access to premises; and
 - (f) to provide new means of access to premises,
