Notice is hereby given that the above-named Order, made on 10th October 1986 is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as an unopposed Order, by the Norfolk County Council.

The effect of the Order, if confirmed without modification will be to modify the Definitive Map and Statement for the area by adding thereto the footpath which leaves the U76372 Wheel Road, Alpington, 35 metres east of its junction with Readers Lane, Alpington, runs north for 230 metres between hedges, then north for 64 metres along the field edge, then east for 14 metres, and finally north for 71 metres to Public Footpath No. 4 Yelverton (a total distance of 379 metres).

If no representations or objections are made to the Order, or if any so made are withdrawn, the Norfolk County Council may, instead of submitting the Order to the Secretary of State for the Environment, themselves confirm the Order. If the Order is submitted to the Secretary of State for the Environment, any representations and objections which have been duly made and not withdrawn will be transmitted therewith.
