This Order which imposes one-way traffic working as follows:

TOWN AND COUNTRY PLANNING ACT 1971

Littleover Local Plan

Notice is hereby given that Derby City Council ("the Council") have prepared the above-named local plan. The plan relates to land in the following districts:

An area of land including parts of the Wards of Littleover, Kingsway, Mickleover, Blagreaves and Norman-ton in the City of Derby.

Certified copies of the plan, of the certificate obtained pursuant to section 14 (5) of the Act and of the statement mentioned in section 12 (3) of the Act have been deposited at the City Secretary's office and the Director of Planning's office, Council House, Corporation Street, Derby, the Littleover Library, Burton Road, Littleover, Derby and the offices of the County Clerk, County Offices, Matlock, Derbyshire.

Since the plan was prepared, in view of information subsequently obtained, the Council has decided to modify

it to incorporate provisions relating to facilities for cyclists at the Uttoxeter Road/City Hospital roundabout. The grounds for proposing the modification are set out in a report which was submitted to Planning and Economic Development Committee on 5th November 1986. A copy of this report together with the proposed modification and the deposited documents referred to in paragraph two above are available for inspection free of charge during normal office hours.

Objections to the plan should be sent in writing to the City Secretary, Council House, Corporation Street, Derby, before 26th January 1987. Objections should state the matters to which they relate and the grounds on which they are made, and may include a request (stating the addresses to which notice is to be sent) to be notified of the decision on the plan. Forms for making objections are obtainable at the places where documents have been deposited.

HIGHWAYS ACT 1980

The Norfolk County Council (A1064 Acle Link Road) (Classified Road) (Side Roads) Order 1986
