Proposed Stopping up of lengths of Gladstone Street, Herbert Street and an unnamed highway at Chadderton

- 1. The Secretary of State for Transport hereby gives notice that on the application of Oldham Metropolitan Borough Council on behalf of Ashdene and Windsor Construction Limited he proposes to make an Order under section 209 of the above Act to authorise the stopping up of lengths of Gladstone Street, Herbert Street and an unnamed highway off Gladstone Street, Chadderton, to enable office and industrial unit development to be carried out in accordance with planning permission granted to Ashdene and Windsor Construction Limited by Oldham Metropolitan Borough Council under Part III of the said Act.
